Safety Data Sheet (SDS) Authoring in ExESS®

Lisam and Praxair have a long-time working relationship that began in Europe many years ago when Praxair began using the legacy Lisam Omnis SDS and labeling software and the associated Gas Classification Modules/GCMs (for gas mixtures). Lisam's Omnis is currently deployed at multiple Praxair operations across Europe. The two companies are also active participants in the European Industrial Gases Association (EIGA) and the Compressed Gas Association (CGA) in North America. Lisam is helping to meet the specific SDS needs of the EIGA and CGA membership through data sharing as well as a template and module development program.

Based on their strong working relationship, Praxair chose to work with Lisam again when looking for a new software solution to update its' MSDSs to GHS in the United States. Using ExESS, Praxair was able to efficiently convert its old MSDSs to compliant GHS SDSs for a wide variety of products. As follow-on to the successful GHS conversion in the United States., Praxair is now starting to roll out ExESS world-wide as a global authoring platform.

ExESS for Label Automation

Working together in the E.U., Lisam and Praxair designed and implemented several customized Omnis add-on programs for semi-automated generation of specialty product labels. These solutions integrate with the inputs and outputs of various enterprise operations and fulfillment systems, and as a result enable highly productive business processes.

Using the flexible ExESS platform, Lisam and Praxair worked to quickly retool ExESS to replace a legacy Praxair internal specialty label creation program with a new GHS-compliant, web-enabled version. The extensive data import capabilities of ExESS also made it easy to bring over Praxair-compiled specialized product data and additional hazards information. This enhanced the Praxair SDS and product label content, ultimately maximizing the safety of end users of Praxair products.

Praxair Leverages Lisam

Praxair used Lisam's Gas Classification module (GCM) for GHS, that leverages their compliance management solution, ExESS, an automated safety data sheet (SDS) content builder that simplifies the creation of documents for gas mixtures. It enables companies within the industrial and specialty gases industry to comply with the latest CGA and EIGA standards, as well as with current regulations. By using the ExESS GCM, Praxair EHS users were able create a fully compliant SDS for a specific gas, by leveraging its' built-in processes which allow users to; build compositions, integrate EIGA approved content, calculate the DPD/CLP classification and transport profile of a mixture, import and export data, leverage CGA and EIGA-approved SDS for 150 pure gases, access classification and labeling information for 300 pure substances and a library of 600 phrases common to gases, in over 20 languages, access ADR / IATA / IMDG dangerous goods lists and print their labels directly from ExESS, including "banana" labels for the Compressed Gas Industry.
